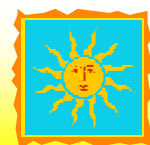
Funding from New Brunswick Environmental Trust Fund



Jonathan Creek In-Stream Structure Evaluation

The Petitcodiac Watershed Monitoring Group is undergoing an evaluation of the in-stream structures placed in Jonathan Creek by the Jonathan Creek Watershed Committee between 1999 to 2001.

These structures, mostly digger logs and deflectors, were placed in three different parts of the stream: above and below Westmorland-Albert Waste Facility, below Horseman Road and Centennial Park.

The evaluation consists of verifying the condition and stability of each in-stream structure, as well as its effectiveness and whether it needs to be repaired.

Cattle Fencing On Two Local Farms

Cattle fencing was installed on two local farms by the PWMG in conjunction with the Moncton Agro-Conservation Club. Funding has been provided by the New Brunswick Wildlife Trust Fund, the New Brunswick Environmental Trust Fund and the Dept. of Agriculture, Fisheries and Aquaculture.

Approximately 1.5 kilometre of fencing was installed on these farms, which are located on Hasty Brook, a tributary of the Petitcodiac River and on Lee Brook, a tributary of Pollett River.

Along with the fencing, fording sites were made and cattle watering devices such as a wind mills were installed.

Both fencing projects were completed at the end of September.
