

PARK AVENUE[®] SWEEPSTAKES

Official Rules:

1. Eligibility: NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING A PRIZE. The “Park Avenue[®] Sweepstakes” (the “Sweepstakes”) is open only to legal residents residing in the geographic areas of the United States serviced by a participating authorized Park Avenue[®] Window Collection dealer (the “Participating Dealer”) as designated by Thermal Industries, Inc. (the “Sponsor”) and is therefore limited to those residents of the states of Alabama, Connecticut, Delaware, Georgia, Iowa, Indiana, Illinois, Kansas, Kentucky, Massachusetts, Maryland, Michigan, Minnesota, Mississippi, Missouri, North Carolina, North Dakota, Nebraska, New Hampshire, New Jersey, New York, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, Tennessee, Texas, Vermont, Virginia, Wisconsin, West Virginia and Wyoming. Valid home address is required. P.O. Boxes and incomplete entry forms will not be accepted by the Sponsor. Mechanical reproductions of entry card will not be accepted by the Sponsor. All potential winners are subject to verification before any prize will be awarded. Limit one (1) entry per household. Sponsor is not responsible for lost, late, incomplete, incorrect, invalid, unintelligible or corrupted entries, which will be disqualified.

5. Sweepstakes: Sponsor’s decisions as to the administration and operation of the Sweepstakes and selection of potential winners are final and binding in all matters related to the Sweepstakes. Sponsor will randomly select the potential GRAND PRIZE winner from all eligible entries on or about January 13, 2013.

6. ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. AN ENTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT’S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE. SPONSOR WILL NOT ACCEPT SCREEN SHOTS OR OTHER EVIDENCE OF ENTRY IN LIEU OF ITS VALIDATION PROCESS. ANY ENTRY THAT IS SUBMITTED AFTER THE SYSTEM HAS FAILED FOR ANY REASON IS DEEMED A DEFECTIVE ENTRY AND IS VOID.

7. Verification of potential winners: Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential Grand Prize winner will be notified by email, telephone or mail after the date of random drawing. If a potential winner of any prize cannot be contacted over a period of five business days or a prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that a potential winner of any prize is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining entries. There will be three (3) alternate drawings after which the prize will remain unrewarded. Prizes will be fulfilled 8-10 weeks after selection of winner.

8. Prizes: One (1) **GRAND PRIZE: \$10,000.00 worth (retail value)** of Park Avenue® Windows Collection products including installation. Odds of winning dependent on the total number of eligible entries received by each drawing date. Prize must be ordered through, and installed by, participating authorized Park Avenue® Windows Collection Dealer as designated by Sponsor. Winner must comply with all terms and conditions in Official Rules. All prizes are non-transferable and no substitution will be made except at the Sponsor's sole discretion. Sponsor reserves the right to substitute any listed prize for one of equal or greater value if the designated prize should become unavailable. In the event the chosen qualified winner has purchased and installed Park Avenue Windows during the Promotion Period, winner may elect to receive a refund of the amount paid, up to prize limit, in lieu of prize. In this case, it is the responsibility of Winner to furnish copy of itemized receipt of payment to Manufacturer.

9. Taxes: Winners will be required to pay to Manufacturer required federal tax withholdings equal to 25% of the prize value along with any applicable state tax withholdings.

Release: Winner agrees to release and hold harmless Participating Dealer and Sponsor, and their respective subsidiary and affiliate companies, suppliers, distributors, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.
