**Closing:** The closing date for entries is August 23, 2010. We reserve the right to refuse any entry.

**Refunds:** Refunds of 75% of entry fees, 100% of stabling fees, only upon presentation of a veterinarian/doctor certificate to the Show Secretary prior to August 31<sup>st</sup>, 2010. We also require notification by phone or fax to the office one day prior to the start of your classes. No refunds will be issued if this procedure is not followed.

**Stabling:** Stalls will be allotted on a first entry basis. Exhibitors will be notified if stabling requests cannot be accommodated. Bedding will be provided. Stall Fees will be \$25.00 for the M. B. R. A. division.

All exhibitors must sign waiver and provide proof of insurance.
